Basenji Rescue And Transport, Inc., a Texas non-profit corporation (BRAT), has established this Contract to detail the specific requirements to which the Breeder must comply as a condition of the Adoption/Transfer of the pet Basenji whose name and description appear above.

**TRANSFER**

Breeder represents that he/she is the original Breeder of the Basenji herein described ("the Basenji"), and hereby waives and transfers all of his/her contractual ownership rights, title and interest in said animal to Basenji Rescue And Transport, Inc. (BRAT). Breeder agrees that any contractual reversionary interests Breeder may have in the Basenji are terminated once Breeder signs this form.

Breeder represents that he/she is not presently able or willing to take back or place the Basenji and releases to BRAT all rights and privileges otherwise afforded the Breeder, to place this Basenji in a new home. BRAT will use its best efforts to place said Basenji in a new home pursuant to the requirements as stipulated in the BRAT Adoption Contract, including mandatory neutering. However, Breeder understands and acknowledges that BRAT may not be able to place the Basenji and that this transfer is without any recourse. All adoption fees for the Basenji will be paid directly to BRAT and Breeder will not be entitled to any portion of such fees.
